VOLUNTEER AGREEMENT AND RELEASE

Assumption Of Risk -- I assume the risk of injury or death which may arise out of the ordinary activities which take place in, around, and traveling to and from Mad Housers functions. I understand that I am volunteering at my own risk and I am aware of the risks involved. I understand that my willingness to assume the risks of injury or damage while volunteering is necessary to protect the Mad Housers not-for-profit organization from any losses due to such potential liability.

Insurance -- I further acknowledge that the Mad Housers does not provide any type of insurance including liability or medical coverage for volunteers. As a volunteer, I am expected to have my own medical insurance policy and/or the means to pay for any and all emergency and non-emergency medical treatment incurred.

Medical release -- In the event of illness or injury, I do hereby consent to whatever x-ray examination, anesthetic, medical, surgical or dental diagnosis or treatment and hospital care considered necessary in the best judgment of the attending physician, surgeon, or dentist and performed under the supervision of a member of the medical staff of the hospital or facility furnishing medical or dental services.

Publicity Release -- As a charitable organization, Mad Housers will occasionally engage in the taking of photographs and other audio or video recordings for publicity purposes. It is assumed that I have no objection to the use of these images/media by Mad Housers for non-profit purposes, unless I tell the Mad Housers volunteer build supervisor otherwise.

I voluntarily agree to assume the aforementioned risks and responsibilities of volunteering for Mad Housers and I voluntarily agree to indemnify, release, discharge, covenant not to sue, and hold harmless Mad Housers, Inc., its trustees, directors, officers, and any other representatives, in as broad and inclusive manner as possible, forever, from any and all actions, claims, and demands for loss, liability, injury, damage, costs, or death which may occur to me or to property belonging to me, resulting from my participation in this Mad Housers' activity, unless caused by Mad Housers' willful act.

Any portion of this document deemed unlawful or unenforceable shall not affect the remaining provisions, and those remaining provisions shall continue in full force and effect.

In signing this release, I acknowledge and represent that I have read the foregoing Volunteer Agreement and Release, understand it, and sign it voluntarily. No oral representations, statements, or inducements apart from the foregoing written agreement, have been made. I am at least eighteen (18) years of age and fully competent. I execute this Volunteer Agreement and Release for full, adequate and complete consideration fully intending to be bound by the same.
